



Compliance Requirements 2021-2022

Students must bring copies of your vaccinations and TB results with you to the first day of the SRNA course

1. TB/PPD

- ◆ Important: TB skin tests will NOT be accepted.
- ◆ Compliance may be obtained by:
 - One IGRA (Quantiferon Gold Blood Test or TSPOT) given in September 2019 or later.
 - If student has a known history of positive TB skin test or IGRA test, they must work with university Health Services (UHS) or another clinic as outlined in the highlighted section below.
- ◆ IGRA blood test documentation must include the following:
 - Student's Name
 - Student's date of birth
 - Date of collection (blood draw); AND
 - Results of blood test documented as non-significant or negative (unless documentation submitted is employee compliance form or UHS compliance form); AND
 - Name of the healthcare provider OR University Health Services (UHS) Compliance form OR Employee compliance form OR state immunization certificate or registry.
 - TB Screening Questionnaire must be completed along with TB blood TEST
- ◆ If student has a known history of positive TB test or IGRA test, the following must be provided:
 - Student's Name
 - Student's date of birth
 - Documentation of positive TB test or IGRA test including name of healthcare provider or UHS compliance form or employee compliance form or state immunization certificate or registry required; **AND**
 - Clear chest x-ray (lab report) required indicating normal/negative **AFTER** positive TB or IGRA test (including name of healthcare provider or UHS compliance form or employee compliance form or state immunization certificate or registry); **AND less than one year old**
 - TB Symptom Questionnaire completed with UHS personnel **less than one year old**

2. MEASLES, MUMPS AND RUBELLA (MMR)

- ◆ Compliance can be obtained by providing:
 - Two MMR vaccines with first dose given at 1 year of age or older AND second dose given at age four or older; OR
 - Documentation of positive antibody titers showing proof of immunity for each of the three diseases: measles (rubeola), mumps AND rubella

- ◆ Documentation must include:
 - Student's Name
 - Student's date of birth
 - If series is completed, dates of each shot **OR**
 - If titers are provided, dates of positive titers are required and information will include: "immune," "positive" or number that when compared to range given on record indicates the student is positive/immune; **AND**
 - Name of the healthcare provider OR UHS compliance form OR Employee compliance form OR state immunization certificate or registry.

Note: If needed, the two-dose MMR series must be completed prior to beginning the nursing program

3. TDaP (TETENUS – DIPHTHERIA ACELLULAR PERTUSSIS)

- ◆ Evidence of one dose of TDaP given at 11 years or older
- ◆ Documentation must include:
 - Student's Name
 - Student's date of birth
 - Date of TDaP shot; **AND**
 - Name of the healthcare provider OR UHS compliance form OR Employee compliance form OR state immunization certificate or registry.

Note: TDaP is a different vaccine than the tetanus (Td) vaccine, which is recommended every 10 years. TDaP is also different than the childhood DTaP vaccine.

4. VARICELLA

- ◆ Please note that oral history is not accepted.
- ◆ Compliance may be obtained by providing:
 - Evidence of varicella two-dose series after one year of age; **OR**
 - Positive antibody titer showing proof of immunity; **OR**
 - Medically documented history of disease from a healthcare provider with date.
- ◆ Documentation must include:
 - Student's Name
 - Student's date of birth
 - If series is completed, dates of each shot; **OR**
 - If titer is provided, date of positive titer is required and information will include: "immune," "positive" or number that when compared to range given on record indicates the student is positive/immune; **OR**
 - If providing medical history, submit medical record from healthcare provider; **AND**
 - Name of the healthcare provider OR UHS compliance form OR Employee compliance form OR state immunization certificate or registry.

Note: If needed, the two-dose Varicella series must be completed prior to beginning the course

5. HEPATITIS B

- ◆ Compliance may be obtained by providing:
 - Evidence of three Hepatitis B vaccines; OR
 - If series is in process or historical documentation of vaccines could not be obtained, 2 vaccines are required upon initial submission to this requirement. You will be able to submit record of the third shot when it is due.
- ◆ Documentation must include:
 - Student's Name
 - Student's date of birth
 - Dates of HEP B shots; AND
 - Name of the healthcare provider OR UHS compliance form OR Employee compliance form OR state immunization certificate or registry.

Note: If needed, the first two HEP B shots must be completed prior to beginning the course

6. INFLUENZA

- ◆ Compliance may be obtained by providing:
 - Evidence of this season's influenza vaccination
- ◆ Documentation must include:
 - Student's Name
 - Student's date of birth
 - Dates of influenza
 - Name of the healthcare provider where influenza vaccination was given
